How to obtain a letter about your S&W firearm. There are two types of letters.

- 1) "Letter of Authenticity" is a letter that includes available information on your model, when and where it shipped and how it was outfitted by the factory.
- 2) "Historical Letter" takes the information from your completed Letter of Authenticity and allows the SWHF to deep dive records to pull up additional information that may be available about your firearm. In some cases this may include copies of original documentation of orders and communications between the original buyer and the factory.
